## SUMMARY OF PROPOSAL

[During the 2020 COE WG, the Secretariat was requested to analyze the work of selected deployed medical capabilities first included in the 2014 and 2017 COE Manual, to establish an equitable reimbursement rate for these capabilities. Selected capabilities are (as listed in the 2020 version of the COE Manual) were the:

- Aeromedical Evacuation Module (Ch 3, Annex C, Appendix 10);
- Orthopaedic Module (Ch 3, Annex C, Appendix 13);
- Physiotherapy Module (Ch 3, Annex C, Appendix 14); and
- Internal Medicine Module (Ch 3, Annex C, Appendix 15)

## PROPOSED TEXT FOR 2023 COE MANUAL

*[Amend Chapter 8, Annex B to include the following:*

<i>Aeromedical Evacuation Module</i>	<i>\$0.22</i>
<i>Orthopaedic Module</i>	<i>\$0.08</i>
<i>Physiotherapy Module</i>	<i>\$0.11</i>
<i>Internal Medicine Module</i>	<i>\$1.61</i>

**Chapter 3 Annex C to include the following:**

**Aeromedical Evacuation Module:** To be eligible for self-sustainment reimbursement for the Aeromedical Evacuation module (AMET), troop/police contributors must be able to provide treatment capabilities and medical equipment, as listed in Chapter 3, Annex C, Appendix 10 and 10.01.



**Orthopaedic Module:** To be eligible for self-sustainment reimbursement for the Orthopaedic module, troop/police contributors must be able to provide treatment capabilities and medical equipment, as listed in Chapter 3, Annex C, Appendix 13 and 13.1.

**Physiotherapy Module:** To be eligible for self-sustainment reimbursement for the Physiotherapy module, troop/police contributors must be able to provide treatment capabilities and medical equipment, as listed in Chapter 3, Annex C, Appendix 14 and 14.1.

**Internal Medicine Module:** To be eligible for self-sustainment reimbursement for the Internal Medicine module, troop/police contributors must provide an Internal Medicine Specialist to be able to provide treatment capabilities, as listed in Chapter 3, Annex C, Appendix 15.
