## PROPOSED TEXT FOR 2023 COE MANUAL

a)

The wording “Actual troop strength” be changed to “**Actual personnel strength**” in:

- Chapter 2 para 8 and para 26
- Chapter 3 Annex B para 5
- Chapter 3 Annex C para 18
- Chapter 4 para 15

b)

Chapter 3 Annex B para 11(b) changed to:

“Provide deep freeze (14 days where required), cold (7 days) and dry (7 days) food storage for kitchen facilities;”

c)

Move all the text in Chapter 4, para 17-20 to a new appendix 4 under Chapter 3, Annex A named Painting and repainting

d)

Update Chapter 3 Annex A para 43 to:

“To be considered serviceable for United Nations operations, all vehicles must be painted white with appropriate United Nations markings. Painting and repainting are covered in greater detail in ~~chapter 4~~ appendix 4 to this annex.”

The UN Movement Manual clearly separates between redeployment and repatriation. The COE Manual uses the redeployment word wrongly

- Update Chapter 2, Annex A with the two new definitions

**Redeployment** is the internal movement of personnel and equipment within the mission area from one location to another or between various UN missions



**Repatriation** is the movement of personnel from a UN mission to a Member State agreed Airport of Entry, and equipment from a UN mission to a Member State agreed Port of disembarkation or Unit location in the home country.
